## **Background**

SAHR is calling for applications from Human Rights Defenders (HRDs) who are seizing an opportunity for law and policy reform, or, litigating a case of strategic interest, to end Sexual and Gender-Based Violence (SGBV).

The objective of the Fellowship is to amplify the knowledge and skills of HRDs who are contributing to litigation, law or policy reform on SGBV. Organizations are also encouraged to nominate HRDs who will benefit from this Fellowship and in turn, contribute back to the organization's own initiatives towards law and policy reform.

## **ABOUT SAHR**

SAHR is a peer-network of human rights defenders from all over the world. Our mission is to fuel a worldwide network of Human Rights Defenders (HRDs) to strengthen laws, policies and practices to end SGBV. We deliver our mission through 2 key initiatives: SAHR Justice Advocacy and SAHR Justice Lab and Fellowship.

## THE FELLOWSHIP

Influencing law and policy is a form of participation and power. Law and policy work has traditionally been the domain of policy-makers and it requires know-how and practical skills in policy/legal communication and writing.

SAHR recognises that to effectively end SGBV, HRDs working at the frontlines must be equipped to effect change at law and policy level. They need to be able to develop a point of view and position a solution. When HRDs can master these skills and speak as co-equals with government leaders, that is when we can truly influence justice and close the gender justice gap.

The objective of this Gender Justice Legal Defenders Fellowship Program is to resource and accompany human rights defenders working to close that gap.

#### Who can apply?

We invite individual applicants under the age of 40 who identify themselves as women, trans and gender-nonconforming to apply.

Organizations are also encouraged to nominate HRDs who will benefit from this Fellowship and in turn, contribute back to the organization's own initiatives towards law and policy reform.

Applicants must be able to demonstrate a commitment to advancing human rights and equal access to justice for women, LGBTQIA+ and gender-nonconforming individuals.

Applicants from all over the world will be considered.

#### How long is the Fellowship?

The duration of the fellowship is 1 year.

#### What do Fellows do during the Fellowship?

They can use the time to work on their projects.

#### What is the fellowship stipend?

Fellows will receive a total stipend of **USD \$3,000.00**. The stipend will be distributed in 3 installments and can be used to cover personal and project-related expenses.

#### What are the reporting requirements?

One short narrative report in the SAHR template due on 14 March 2024. No financial report on use of stipend is needed.

## What are expected of Fellows?

Work on their projects towards law/policy reform or case in their countries.

- Fellows are expected to run 2 workshops or roundtables in their community to encourage people's participation in high-level change-making.
- Participate in 3 SAHR Justice Lab workshops (1 hour each, once every quarter) which will be designed to support Fellows in their projects.
- Submit one simple narrative report at the end of the Fellowship.

### What can Fellows expect?

On a needs-basis, Fellows can expect support and mentorship of peer experts in SAHR's network. Through SAHR Justice Lab workshops, Fellows will chart out their change theory, get constructive feedback on their work and learn about solutions used in other countries. They will also ultimately strengthen their command and use of international human rights standards in their work.

## **Eligibility Criteria**

Fellows who fulfill the below criteria will be eligible to apply:

$\checkmark$	Do you identify as a woman, trans or gender non-conforming person?
$\checkmark$	Are you a human rights defender with experience in community organizing or
	activism?
$\checkmark$	Can you demonstrate that you are working on an existing or high-potential case, or law
	and policy reform initiative in your country?
$\checkmark$	Are you addressing issues involving survivors from under represented and under
	resourced communities who are rendered vulnerable by intersecting inequalities,
	including survivors living with disabilities; LGBTQIA2S ¹persons; afro-descendants;
	indigenous persons; ethnic, religious and caste minorities; migrants; and those living
	in urban slum areas, rural areas, refugee camps, occupied territories and in
	conflict-affected settings?

Please note that SAHR will only support projects related to a specific law and policy reform initiative or a systematic case of gender-based violence. Applications concerning academic research or activities or financial support for attending training will not be supported.

<sup>&</sup>lt;sup>1</sup> The acronym LGBTQIA2S stands for Lesbian, Gay, Bisexual, Transgender, Queer and/or Questioning, Intersex, Asexual, Two-Spirit, and the countless affirmative ways in which people choose to self-identify.

#### APPLICATION PROCESS

Please submit this completed <u>application form</u> in English.

A full proposal consists of:

- The application form. You may preview all the questions on the application form here.
- Your resume or CV (uploaded to the application form)
- One letter of recommendation (uploaded to the application form)
- [Optional] 2-3 minute video recorded by your phone about YOU and your project (uploaded onto the form, or sent via Whatsapp to +39-349-94-17-215).

Full proposals are to be submitted in English.

We will not consider multiple submissions from the same applicant or proposals that include several project ideas in a single submission.

Previous applicants of SAHR Gender Justice Fellowship are eligible to reapply on the basis of the previously submitted project or a new project.

The selection panel will only invite a limited number of candidates to interview. If you are selected, we will notify you at least two weeks in advance of the interview.
